His feeling is that many voters, who do not understand or are undecided on a warrant, would vote according to the recommendations. A split recommendation would only further confuse voters. A discussion ensued regarding need and what the warrant article would actual involve.

Mr. Stokinger explained, since we have not filed the final paperwork for the last construction project, the district would qualify for State aid reimbursement as long as the work is part of the original scope of construction. The ventilation system qualifies for the reimbursement. He stated this would be the last time we could ask for state aid for this project.
