

Dr. McDonald is working on the budget figures, the elementary school, Facilities and SPED will be presenting their budgets this Thursday in a joint meeting with the Budget Committee. Dr. McDonald noted the importance of the SRO position at the Middle School, which is under consideration. It was noted that the SRO discussion should be added to the next agenda.

Mr. Baldwin inquired about the mentoring program, Dr. McDonald reviewed the three-year program for new teachers. It is a good solid program.

It was noted that the retirement cost for the district would increase from 3.7% to 5.8% for teachers. Support staff will increase from 6.84% to 7.82%.
