Eligibility:

- Juniors and seniors who have completed or currently in their third class within the Business and Technology Department (list of courses on back)
- All candidates must submit completed applications by Thursday, September 10, 2020 to Dr. Bibeau or Ms. Takesian.

Academic Criteria:

- **3.5 GPA in Business Courses**
- **3.0 GPA overall**

Additional Criteria:

Students selected for recognition will have demonstrated, both in the classroom and through extracurricular involvement, the following:

- *Character*
- *Leadership*
- *Service*

Application, Selection, and Recognition Process

- Student may initiate the process or the department may solicit applications from worthy candidates.
- Business Honor Society Advisor(s) verify eligibility and selects students.
 - Committee of business educators (minimum of 3) will decide membership
 - A list of potential members will be distributed to all business staff for review
 - Students may be denied if any one of the criteria is not met
- Selected students will be honored at an induction ceremony
- Business Department completes certificates, prepares and sends a congratulatory letter to each student with an additional copy sent to the school guidance department
- Honorees will be awarded a National Business Honor Society pin and cord at graduation

Member Community Service Project

- National Business Honor Society Members will offer five hours of community service either on their own (verifiable and solely used for National Business Honor Society) or on an agreed upon project that the members wish to complete together as a group.
