School Guidelines for Managing Students with Life Threatening Food Allergies

Family's Responsibility

- Notify the school of the child's allergy(s), prior to entry into school or immediately after a diagnosis of a life threatening allergy is made.
- Provide emergency information and phone contacts to the school before the first day of school.
- Work with the school nurse to develop a Food Action Allergy Plan and/or Individual Emergency Health Care Plan. Photo will accompany plan as necessary.
- Provide written medical documentation, instructions and medications from the student's doctors as per TRSD policy.
- Replace medications after use or expirations as needed.
- *Provide the teacher with safe snacks for the student during classroom parties or unplanned events involving food.
- Provide information regarding student's allergy to bus driver, bus company, or any staff member facilitating any extracurricular activity and set up a plan with them in case of an emergency.
- Educate the child in self- management of their food allergies including:
 - o Safe & unsafe foods
 - Strategies for avoiding exposure to unsafe foods and what to do if the child has been exposed
 - Symptoms of allergic reactions
 - o How and when to tell an adult they may be having an allergy related problem
 - *How to read food labels

School's Responsibility

- The School Nurse will review the records submitted by parents and physicians and develop an Emergency Action Plan, and/or Individual Emergency Health Care Plan/504 Plan in coordination with the parent(s) as necessary. These plans will be kept in the student medical file and distributed to all appropriate staff.
- The school nurse will educate school staff on signs & symptoms of severe allergic reactions, food allergy awareness, and Epi-Pen use.
- Food allergy awareness literature, which list signs & symptoms of severe allergic reaction will be made available to all staff.
- The school nurse will review the Emergency Action Plan or Individual Emergency Health Care plan at least one time per year with appropriate staff and make changes as necessary.
- The <u>School Team</u>, consisting of school nurse, food service manager, teacher, principal, etc., will work with parents and student to establish a management plan, i.e. creating an allergen sensitive classroom, lunch room table, etc. as needed.
- The school nurse and/or teacher will educate other students as appropriate in avoiding/endangering exposure of allergens, stigmatizing or harassing classmates with food allergies.
- Include food allergic students in school activities. These students should not be excluded from school activities based solely on their allergies.

Cafeteria

- *Students may sit at an assigned allergen sensitive table, unless parent/doctor requests otherwise. This table will be appropriately marked so that other students and staff will be aware.
- *Cafeteria monitors will be responsible for making sure that lunches of any student sitting at that table are nut/peanut sensitive to the best of their knowledge and ability.
- Cleaning utensils/cloth/bucket etc will be used exclusively for the allergy sensitive table.
- Cafeteria tables will be cleaned before and after use.
- *Students in allergen sensitive rooms will wash/wipe their hands immediately after lunch.
- Epi-Pens will be kept in an easily accessible area as appropriate.
- Lunch menus are available on the school/district website for parents to view.

Classroom

- *Students with life threatening food allergies may be placed in an allergen sensitive classroom as deemed appropriate by the School Team, parent(s) and/or physician.
- *A sign will be posted at the entrance of the classroom indicating allergen sensitive classroom.
- *Food containing the allergen (nuts, etc.) shall not be used in class projects or as manipulative tools.
- *Student should be placed in a classroom with a sink if possible.
- Student should have his/her own cubby/locker when possible.
- *A letter will be sent to parents of the students' classmates before the start of school informing them that the classroom will be allergen sensitive.
- *Additional field trip accommodations should be made as necessary. Parent may be encouraged to accompany the student on field trips.
- *The student should only eat snacks provided or approved by the parent during classroom parties or unplanned events involving food.
- *All students in the allergen sensitive classroom shall wash/wipe their hands after snack in the classroom.
- *Staff will be responsible for making sure that snacks are allergen sensitive snacks to the best of their knowledge and ability. If there is a question, the parent should be contacted with the assistance of the school nurse.

Student's Responsibility

- Should not trade or share food or utensils with others.
- Should not eat anything with unknown ingredients or known to contain allergen.
- Should be proactive in the care and management of their food allergies and reactions based on his/her developmental level. This include learning to recognize early symptoms of reaction.
- Should notify an adult immediately if he/she has eaten/touched something he/she believes may contain the food to which he/she is allergic.
- Should only eat foods provided or approved by the parent.
- Should not eat any foods on the bus per TRSD policy.
- * Indicates items that may be suggested if age appropriate.
