Final Decisions on the any limits to the scope of work shall be noted in the agreement/contract once project costs have been evaluated by the district. The District will will discuss and negotiate any additional modifications or clarifications made after the proposal due date with the selected contractor prior to incorporating them into and agreement. Contractor will provide an agreement including detailed scope of work.

All contractors/companies submitting bids must furnish labor, materials, tools, and equipment necessary to perform the task and do all else, reasonably implied as necessary for the prompt and satisfactory completion of the contract

All companies performing work are advised to conduct work with the latest revisions of Code and New Hampshire State Law, with skilled boilermakers and welders who are trained technicians and certified to complete the task. Emergency numbers (including home phone numbers) are to be provided to the Director of Plant Operations and any project supervisors. The contractor must employ service technicians all having a minimum of three (3) years' experience in the installation and maintenance of boilers with valid Gas licenses as well as workers com and liability coverage in excess of \$1,000,000.

Be advised that boilers can be worked on during the school days. Every effort will be made by successful contractor to ensure that safety be of prime importance, so as not to risk any occupant of the building.
