## Request for Bid: TRSD Heating Oil

SAU 106 (Timberlane Regional School District "TRSD") is requesting sealed Bids for providing fixed price #2 heating oil for four schools for the 2022-2023 heating season per the specification document attached. All sealed bids need to be submitted by Thursday, August 11, 2022, by 11:00 AM with a bid opening at 11:00 AM.

The bidder shall submit a statement with the bid, indicating school experience, together with the names of the school districts previously and/or currently served, the dates involved, and the scope of the services performed.

Proposals must remain firm for 48 hours after the bid opening.

The SAU may make investigation, as they deem necessary to determine the ability of the Bidder to perform the work. The Bidder shall furnish to the SAU all such information and date for this purpose as the SAU may request. The Superintendent reserves the right to accept or reject any and all bids or any item(s) thereof, and to waive any informalities in the bid process and to cancel in part or in its entirety the request for bid and to award the contract as the Superintendent deems to be in the best interests of the School District. The School District further reserve the right to select the bid that best meets the Districts' needs as determined by the Superintendent. While price will be a substantial factor in the decision, the Superintendent reserves the right to select a vendor without the lowest cost proposal.

Any deviation from the conditions and specifications must be clearly expressed by each Bidder in the appropriate space on the bid form/proposal. Unless so stated by the Bidder and accepted by the Districts all conditions and specifications apply.

Any fraudulent or inaccurate statements or willful concealment of relevant information by the Bidder are grounds for rejection of that bid and for the termination of any subsequent contract there from. Bidder may not withdraw bids after bid opening.

The successful Bidder, hereinafter referred to as the contractor, shall be prepared to enter into a written contract with the school district upon written acceptance of the bid by the District. The term of the contract will extend until June 30, 2023.

Final decisions on quantities and any limits to the scope of work shall be noted in the agreement/contract once project costs have been evaluated by the district.

All contractors/companies submitting proposals must furnish labor, material, tools, and equipment necessary to perform the task and do all else, reasonably implied, as necessary for the prompt and satisfactory completion of this contract.

All bids must be in a sealed envelope marked "RFB-Heating Oil" and addressed to the Superintendent of Schools, 30 Greenough Road, Plaistow, NH 03865 no later than **Thursday, August 11, 2022, by 11:00 AM with a bid opening at 11:00 AM.**
